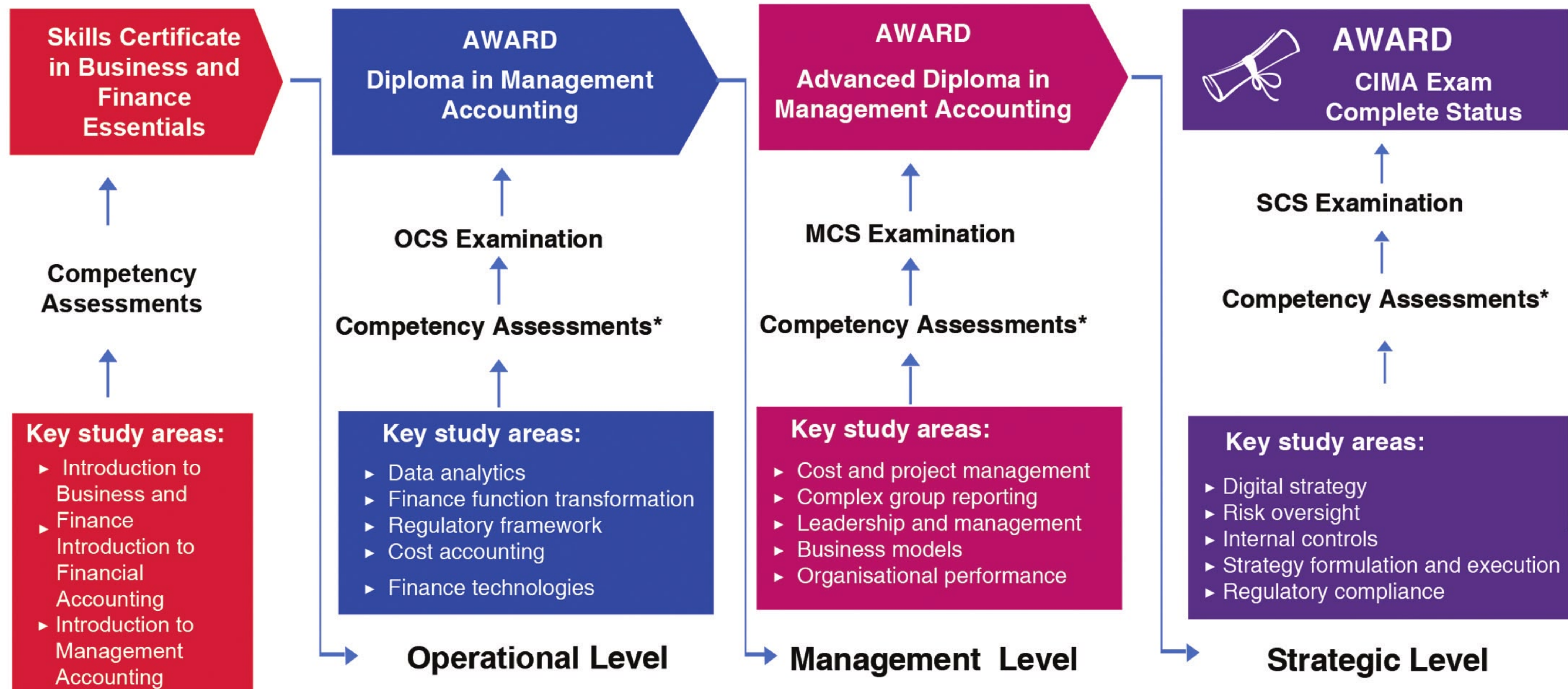

PROGRAMME STRUCTURE

The program is structured into three levels of learning where each level builds upon the previous level



Certificate Level (Essentials)

- Competencies given in the CGMA Competency Framework are trained and assessed
- Learning and assessments are self-paced and delivered online to allow students to fit the program into their schedule
- Students are required to pass assessment questions after each topic, complete business simulations and must pass one case study examination per level to complete the programme

No exams for OTQ subjects, instead COMPETENCIES ARE TESTED through Progressive COMPETENCY ASSESMENTS

Award	After completing either route, learners become CIMA members and are awarded the use of CIMA designatory letters (ACMA or FCMA), as well as the CGMA designation.
